CHANGES IN THE FIELD OF PUBLIC PRIVATE PARTNERSHIPS

- Law of the Republic of Tajikistan “On Concessions” was adopted in 2011
- The Law of the Republic of Tajikistan “On public private partnership” was adopted in 2012.
- State Committee for Investment and State Property Management of the Republic of Tajikistan was determined by the decision of the Government of the Republic of Tajikistan in 2013 as the authorized state body for public-private partnership.
- State institution "Center for the implementation PPP projects" was established by the decision of the Government of the Republic of Tajikistan in 2013.
- PPP of Council was established by the decision of the Government of the Republic of Tajikistan in 2013.
- Methodological guidelines for the preparation and implementation of the projects of the PPP were adopted by the decision of the State Committee for Investment and State Property Management of the Republic of Tajikistan in 2014.



PPP PROJECTS IN THE REPUBLIC OF THE TAJIKISTAN

- ❁ Currently, with the conclusion of an agreement between state authorities and private partners in accordance with the decisions of the PPP Council 14 projects have been implemented in energy, transport, education, health, water and waste management sectors of Tajikistan by using PPP scheme, which is worth more than 396 mil. somoni (more than 40 mil. USD).
- ❁ By the decisions of the government of the Republic of Tajikistan, two concessions projects has been implemented
