## Concept Note and Agenda

#### I. Background

United Nations Regional Commissions have worked closely with member states and other stakeholders in their respective regions to conduct regional reviews of the Programme of Action of the International Conference on Population and Development (ICPD). These reviews, carried out in collaboration with the United Nations Population Fund (UNFPA), took place as follows:

- Economic Commission for Africa (ECA): African Population Experts Committee and Ministers in Charge of Population Meetings on the 10-year Review of the Addis Ababa Declaration on Population and Development (AADPD), Lusaka, Zambia, 7–10 November 2023.
- Economic Commission for Europe (ECE): Regional Conference on International Conference on Population and Development (ICPD), Geneva, Switzerland, 19-20 October 2023.
- Economic Commission for Latin America and the Caribbean (ECLAC): Fifth meeting Presiding Officers of the Regional Conference on Population and Development and Special session "10 years of the Montevideo Consensus on Population and Development", Santiago, Chile, 14-15 November 2023.
- Economic and Social Commission for Asia and the Pacific (ESCAP): Seventh Asia and the Pacific Population Conference, Bangkok, Thailand, 15-17 November 2023.
- Economic and Social Commission for Western Asia (ESCWA): Arab Regional Conference on Population and Development: Challenges and Prospects Ten Years after the 2013 Cairo Declaration, Beirut, Lebanon, 13–14 September 2023.
