

Summary Assessment

Committee on Energy Third session 24-26 February 2021

I. Introduction

The third session of the Committee on Energy took place on 24-26 February 2021 as a virtual meeting due to ongoing COVID-19 related travel restrictions in many countries in the Asia-Pacific region.

An online questionnaire assessing the relevance, effectiveness and quality of the meeting was conducted.¹ The main purpose of the assessment is to support the secretariat's ongoing efforts to improve its servicing of the session.

The Committee session provided a platform to review the progress made towards the attainment of the Sustainable Development Goal 7 on sustainable energy, address regional and national policies and measures that have supported achieving targets of the Goal 7 on energy access, renewable energy and energy efficiency. It also reviewed the draft regional road map on power system connectivity: promoting cross-border electricity connectivity for Sustainable Development as requested by the Commission at its 76th session.

II. Attendance

The third session of the Committee on Energy was attended by 64 per cent of all ESCAP members and associate members (40 of 62) with 2 participants at the ministerial level. There were 143 registered participants from member and associate members, of whom 50 were female (35 per cent). A number of United Nations bodies, agencies, intergovernmental organizations, and non-governmental organizations participated. From these entities, there were 41 participants of whom 12 were female (29 per cent). Therefore, the total number of participants from both governments and other entities was 184 individuals and the total number of female participants was 66 (34 per cent).

III. Respondent's Profile

A total of 20 individual respondents from 16 member countries and 4 from UN specialized agency, intergovernmental and international organizations provided feedback to the questionnaire. Of these 20 respondents, 14 are male, 6 are female.

- May add some discussants to assist moderator eg. during Q&A, More elaborated wrap up at the end of each session.
- Based on assessments and comparisons to choose a more simple and efficient tool for virtual meetings

VIII. Results achieved

 efforts and initiatives being rendered in the Asia-pacific region; way forward in achieving
 collective goal delivery of a resilient, sustainable and smart energy systems for common

- Enhance collaboration among countries and partners to achieve national energy targets.
- The current issues updated in member states. Various Insights from all speakers.
- Energy Connectivity concept to be discussed further among Pacific Countries member states
- The session provided an opportunity to learn about the developments in the energy sector in the region, as well as to discuss further steps to deepen cooperation.
- More regional cooperation in this field.
- Hope to know clearer ideas of most possible electricity needs to be traded between countries in future.

IX. Comments and suggestions

The respondents provided comments and suggestions for improvement of future sessions:

- Thank you for continued support and assistance.
- Material preparation in advance is highly recommended with ample time for audiences.
- Well wrap up with way forward after each session.
- More action-oriented discussion with input from grassroots level.
- Some documents or reports need to be sent beforehand in order to prepare comments.
