Proposed therein are strategies and policy recommendations to address those challenges in support of the implementation of the 2030 Agenda for Sustainable Development.

The Committee may wish to encourage members and associate members to deliver succinct country statements highlighting national experiences and policies, including those on social protection, that have contributed to inclusive social development, advanced gender equality and empowered vulnerable groups. The Committee may also wish to provide guidance on the future work of the secretariat on the topic, particularly in light of the 2030 Agenda.

3. Strategies for strengthening social protection in the implementation of the 2030 Agenda for Sustainable Development in Asia and the Pacific

Annotation

The Committee will have before it a note by the secretariat containing an overview of how the region is performing in social development. The note also discusses key strategies to advance inclusive social protection and identifies options for countries to invest more in social protection and broaden coverage to close social development gaps.

The Committee is encouraged to provide guidance on how the secretariat can support national and regional efforts to promote social protection. Representatives may also wish to deliver succinct country statements highlighting planned and ongoing national measures to strengthen social protection coverage with the aim of reaching the furthest behind. The Committee may also wish to discuss the need for strengthening regional cooperation on social protection for reaching Sustainable Development Goal target 1.3 of the 2030 Agenda for Sustainable Development.
