Annotation

Foreign direct investment (FDI) has long been recognized as an engine of growth and development, in particular as it constitutes an important source of financing for development. It has become increasingly apparent that not only the inward but also outward FDI flows of a given country can make a contribution to its national development. However, the COVID-19 pandemic has severely disrupted global and regional FDI flows. Document ESCAP/CTI/2021/2 contains a discussion of how Governments can adapt their efforts to promote both inward and outward FDI with a view to achieving sustainable development in an era characterized by a new normal.
