

Summary Assessment

Committee on Trade and Investment Seventh session 27-29 January 2021

I. Introduction

The seventh session of the Committee on Trade and Investment took place on 27-29 January 2021 as a virtual meeting due to ongoing COVID-19 related travel restrictions in many countries in the Asia-Pacific region.

An online questionnaire assessing the relevance, effectiveness and quality of the meeting was conducted.¹ The main purpose of the assessment is to support the secretariat's ongoing efforts to improve its servicing of the session.

The Committee session discussed the review of recent trends and developments in trade and investment in Asia and the Pacific, including the impact of rising protectionism and the COVID-19 pandemic; promoting inward and outward foreign direct investment in the post-COVID-19 era; and the work of the secretariat and associated results and future focus pertaining to trade and investment under the subprogramme on trade, investment and innovation.

II. Attendance

The seventh session of the Committee on Trade and Investment was attended by 73 per cent of all ESCAP members and associate members (45 of 62) with 2 participants at the ministerial level. In total, there were 161 registered participants, of whom 66 were female (41 per cent). A number of other entities participated, including United Nations bodies and agencies, intergovernmental organizations, and non-governmental organizations. From these entities, there were 16 participants of whom 3 were female (18.7 per cent). Therefore, the total number of participants from both governments and other entities is 178 individuals and the total number of female participants is 69 (38.8 per cent).

III. Respondent's Profile

A total of 25 individual respondents from 20 member countries provided feedback to the questionnaire. However, 22 completed and 3 partially completed the questionnaire. Information contained in this assessment will therefore only considered the completed feedback of the 22 respondents. Of these 22 respondents, 13 respondents are male, 9 are female. All respondents represent the government.

IX. Comments and suggestions

The respondents provided comments and suggestions for improvement of future sessions:

- Propose to organize specific events to increase knowledge on international trade among the ESCAP member states
- Definitely, need some more time for governments especially of LDCs to adjust themselves to such new technologies for virtual interfaces, use of digital infrastructures, newly created instruments of long-distance interactions, needs proper internet connections, etc. Therefore, it is necessarily important to provide some more capacity buildings for Government entities and senior staff of LDCs in the Asia and Pacific region.
- Please make sure that the link is provided at a time to each delegate. Besides, before every meeting it is needed to remind the participants at least one hour prior through email.
- Providing capacity building and preferential treatment to LDCs such as Afghanistan
- Documents were not received ahead of time so that did not help at all.
- Please grant access for one delegate in one account.
- Need to make the meeting more participating.

X. Conclusion

Overall, delegations agreed that the seventh session of the Committee on Trade and Investment was well organized and fruitful. The session was generally relevant to promote regional cooperation and multilateralism in the area of trade and investment, in particular in the area of digital trade. The efficiency and effectiveness of the session also received positive feedback, in particular, the organization of the session was conducted in a timely manner and according to the programme.
