# Kiribati CRPD Legislative Review

# **CRPD** and Training-of-Trainers Workshops

14 - 16 February 2024, Tarawa, Kiribati

## **Concept Note**

#### A. Background

- 1. The United Nations (UN) Convention on the Rights of Persons with Disabilities (CRPD), including its Optional Protocol, was adopted by the United Nations General Assembly (UNGA) in December 2006, opened for signature on 30 March 2007, and entered into force in May 2008. As the first comprehensive human rights treaty, the CRPD seeks to respect, protect and fulfil the rights of persons with disabilities. It also marks a paradigm shift from a traditional welfare and medical understanding of persons with disabilities as objects of charity to a social model of disability that empowers them as rights holders to enjoy all human rights and fundamental freedoms, and dignity.
- 2. Kiribati acceded to the CRPD on 27 September 2013, signifying the commitment of the Government of Kiribati (hereinafter "Government") to improve lived experiences and human rights of persons with disabilities, tackling the deep attitudinal, pursuing societal, structural and institutional reforms to implement disability inclusive development that would improve the life opportunities of citizens with disabilities. This effort, led by the Ministry of Women, Youth, Sport and Social Affair (MWYSSA), with the development of the first Kiribati National Disability Policy and Action Plan (KNDPAP) 2018-2021, launched in 2018.
- 3. The Kiribati National Human Rights Task Force (KNHRTF), established in 2014, submitted <u>Kiribati's Initial Report</u> (hereinafter "Initial Report") to the Committee on the Rights of Persons with Disabilities (hereinafter "CRPD Committee") in February 2019, following the obligations set out in Article 35 (Reports of States Parties) of the CRPD. Following which, the Committee submitted a <u>List of issues in relation to the initial report of Kiribati</u> (hereinafter "List of Issues) in April 2023.
- 4. Between the submission of the Initial Report to the CRPD Committee and the issuance of the List of Issues, the Government, through the Office of the Attorney General (OAG) and MWYSSA, communicated a technical assistance request to the conduct a review of legislations of Kiribati in compliance with the CRPD (hereinafter "Legislative Review")<sup>1</sup> and a

review of the KNDPAP 2018-2021 to inform the new edition of KNDPAP. The recommendations from these two reviews include:

- Developing a standalone Disability Inclusion Act; and
- · Mainstreaming of disability rights into existing legislations.




Figure 1 Timeline of Kiribati's CRPD initiative

#### B. Workshops' Objectives

5. The part of the Government stakeholders engagement effort, the CRPD Workshop and Training-of-Trainers (ToT) Workshops will be held back-to-back from 14 to 16 February 2024 at Te Toa Matoa, Nanikaai, Tarawa, Kiribati.

Community (SPC) and the Office of the United Nations High Commissioner for Human Rights (OHCHR).

- 6. The CRPD Workshop serves as a validation process, seeking further input to finalize the Legislative Review. The ToT Workshop aims to strengthen awareness on the CRPD through socialization and application of CRPD principles at community-level, enhance understanding of compliance gaps in the national laws, and build capacity for future CRPD-related reporting.
- 7. Both CRPD and ToT Workshops also aim to serve as a preparatory exercise and capacity building for the relevant key stakeholders to implement the recommendations to develop a standalone Disability Inclusion Act and to mainstream disability rights into existing legislations.
- 8. The CRPD Workshop will be mainly facilitated by ESCAP Consultants, Ms. Hasna Cheema and Mr. Tearinaki Tanielu, as well as ESCAP Regional Adviser for Micronesia, with the support of staff members of MWYSSA. The ToT Workshop will be led by ESCAP Consultants, Ms. Hasna Cheema and Mr. Tearinaki Tanielu, and facilitated by staff members of MWYSSA, as well as Disability Inclusion experts from Te Toa Matoa (TTM) and other organizations of persons with disabilities (OPD) as resource persons.

#### C. Target Participants

- 9. The target participants are stakeholders from the relevant line Ministries, in particular KNHRTF, and non-governmental organizations (NGOs), including TTM, the Kiribati School & Centre for Children with Disabilities (KSCCD), the Kiribati Deaf Association (KDA) and other OPDs, as well as faith-based organizations (FBO).
- 10. Approximately 30 representatives are envisaged to participate in the CRPD and ToT Workshops, including facilitators, moderators and speakers.

#### D. Expected Outcomes of the Workshops

- 11. The outcomes of the CRPD Workshop are expected to validate, as well as update and refine, if required, towards completing and finalizing the Legislative Review.
- 12. The outcomes of the ToT Workshop are expected to increase knowledge and application of CRPD principles, enhance understanding of CRPD compliance gaps in the national laws, and strengthen capacity in preparing future CRPD-related reporting.
