Social development trends and challenges in the context of the development agenda beyond 2015 (E/ESCAP/CSD(3)/1)

Annotation

The Committee will have before it a background document that provides an overview of key social development trends and challenges in the Asian and Pacific region, particularly focusing on inequality trends and analyses with special attention to the situation of women and disadvantaged social groups, including youth, persons with disabilities, older persons and migrants. The analysis will draw from the key lessons learned from the regional implementation of the Millennium Development Goals and other internationally and regionally agreed development goals.

Delegations will be expected to deliver succinct country statements highlighting national experiences in reducing poverty and tackling inequalities, particularly focusing on their social and economic impacts on women and disadvantaged social groups. The outcome of the deliberations is intended to provide policy recommendation on means of strengthening the social pillar, as well as its integration with the economic and environment pillars, of the sustainable development agenda beyond 2015.

Asia-Pacific road map for the 20-year review of progress in the implementation of the Beijing Declaration and Platform for Action (E/ESCAP/CSD(3)/2)

Annotation

The year 2015 marks the twentieth anniversary of the Beijing Declaration and Platform for Action of the Fourth World Conference on Women. Under this agenda item, the Committee will consider the regional process and expected outcomes of the 20-year review of progress in the implementation of the Beijing Declaration and Platform for Action in Asia and the Pacific. ¹ Regional preparations have been initiated, including preparations for the convening by ESCAP, in cooperation with UN-Women, of the Asian and Pacific Conference on Gender Equality and Women's Empowerment: Beijing+20 Review in Bangkok from 10 to 14 November 2014.

As a basis for its deliberations, the Committee will have before it a secretariat document outlining the regional review process, which comprises three tracks: (a) research and analysis; (b) intergovernmental consensus building; and (c) stakeholder engagement.

The Committee will be invited to review the Beijing+20 regional review process and consider means of optimizing the engagement of member States, including ensuring high-level ministerial participation in the Asian and Pacific Conference on Gender Equality and Women's Empowerment: Beijing+20 Review.
