The secretariat will provide an update on its ongoing work on vital statistics in response to a request made by the Committee at its first session. Document E/ESCAP/CST(2)/3 presents the outcome of the Forum on the Improvement of Vital Statistics and Civil Registration, which was held from 23 to 25 June 2010 and attended by representatives of national statistical offices, civil registration offices and ministries of health from the region, while also outlining the institutional and partnership arrangements necessary for the development of a regional programme on vital statistics in Asia and the Pacific. The proposed regional programme for the improvement of economic statistics in Asia and the Pacific aims to elevate the capacity of countries in the

Asian and Pacific region to produce basic economic statistics in accordance with international standards and good practices. It was prepared by the secretariat under the guidance of the Bureau, in close consultation with national experts and in cooperation with key subregional, regional and international partners, including the Technical Advisory Group on the Development of Economic Statistics. This multi-year programme was developed in response to a request made by the Committee on Statistics at its first session and will serve as a road map for the region as it aims to address the constraints that prevent countries from producing the core set of economic statistics necessary for effective monitoring and decision-making. The Committee may wish to review and endorse the proposed regional programme and provide advice on its implementation. The Committee may also wish to encourage all of its members to endorse the proposed regional programme as a formal strategy for the improvement of economic statistics in the region.

The Committee will have before it a note by the secretariat (E/ESCAP/CST(2)/8) providing an overview of the factors that shape the statistical training opportunities available to ESCAP member States. The document, which is based on information furnished by providers of statistical training in the region, provides information on the volume, content, coverage and modality of training and reviews the process by which providers of statistical training determine and prioritize the training needs of their stakeholders. It also discusses the views of statistical training providers on the main challenges they face in remaining relevant, effective and efficient, and the strategies and approaches they are taking to effect the improvements and changes needed to meet these challenges. The Committee may wish to discuss and identify mechanisms for developing and implementing a regional approach to the coordination of statistical training among training providers that could strengthen and support their ability to better meet the needs of member States.

### **(b) Coordination mechanism**

The Committee will be briefed on the outcomes of the meeting of the coordination mechanism entitled "Partners for Statistics Development in Asia-

Pacific”, which is scheduled to be held on 14 December 2010 in response to a request made by the United Nations Statistical Commission at its fortieth session for the ESCAP secretariat to “establish an informal mechanism for donor coordination for statistical development in the region, taking into account existing mechanisms, roles and responsibilities (see E/CN.3/2009/29). The Committee may wish to review and discuss the current support for statistical development in the region and endorse the proposed strategy of the coordination mechanism.
