The Committee will have before it a note by the Bureau which provides an overview of recent major developments at global and regional levels regarding data and statistics in support of monitoring of and accountability for the emerging development agenda beyond 2015. The note contains a summary of priority issues and a proposal consisting of strategic approaches for the Committee to undertake to better meet the demands for data and strengthen statistics development in Asia and the Pacific.

The Committee is invited to consider the proposal by the Bureau on regional statistics development for the successful implementation of the development agenda beyond 2015.

The Committee is invited to review progress in implementing the Regional Programme for the Improvement of Economic Statistics in Asia and the Pacific and extend guidance and recommendations to ensure its continued successful implementation and contribution to the successful implementation of the development agenda beyond 2015.

(b) Population and social statistics

Developing a regional strategy to improve population and social statistics in Asia and the Pacific (E/ESCAP/CST(4)/3)¹

Annotation

The Committee will have before it a note by the Technical Advisory Group on Population and Social Statistics on the process and consultations undertaken to strengthen national capacity in population and social statistics. The note outlines the regional strategy developed by the Technical Advisory Group in pursuance of Committee recommendation 3/1 to use the core set of population and social statistics as a regional framework for focusing efforts, coordinating training and mobilizing donor support for capacity development, which was subsequently endorsed by the Commission in its resolution 69/16.

The Committee is invited to review and endorse the regional strategy for population and social statistics. The Committee may also wish to review the work of the Technical Advisory Group and provide guidance on using the core set and the regional strategy for strengthening national statistical capacity in support of the successful implementation of the development agenda beyond 2015.

(c) Civil registration and vital statistics

Annotation

The Committee will have before it a note by the Regional Steering Group for Civil Registration and Vital Statistics in Asia and the Pacific. This note will present progress in pursuance of Committee recommendation 3/2 and Commission resolution 69/15, particularly noting the convening of the Ministerial Conference on Civil Registration and Vital Statistics in Asia and the Pacific, which was held in Bangkok from 24 to 28 November 2014.

The Committee will also have before it a revised terms of reference for the Regional Steering Group, which was completed in response to the request of the Commission through resolution 69/15 that the Regional Steering Group consider and propose a more appropriate governance structure. The revised terms of reference were prepared by the Regional Steering Group and supported by the Ministerial Conference.

The Committee is invited to take note of the outcomes of the Ministerial Conference and review the revised terms of reference for the Regional Steering Group, and recommend that the Commission adopt them.

(d) Environment statistics

Annotation

The Committee will have before it a note by the secretariat on a strategic approach to improving environment statistics in Asia and the Pacific. In pursuance of Committee decision 3/5, this note considers major environmental challenges of the region and the requirements of the development agenda beyond 2015, and emphasizes the importance of integration across data sources and domains of statistics.

The Committee is invited to provide guidance and recommendations on the proposed strategy.

This note will present the work of SAB-AP since its establishment through Committee decision 3/5, including a proposed revision to the terms of reference of SAB-AP, and will provide an overview of recent developments in the field of modernization of statistical production and services at regional and global levels.

The Committee is invited to review the work of SAB-AP, endorse the proposed revision to the terms of reference, and extend guidance and support on the current priority areas.

(g) Gender statistics

Developing a core set of gender indicators for Asia and the Pacific (E/ESCAP/CST(4)/9)

Core set of gender indicators for Asia and the Pacific (E/ESCAP/CST(4)/10)

Annotation

The Committee will have before it a note by the secretariat on recent regional and global calls for improvement of gender statistics and indicators, and the process and consultations undertaken by the secretariat to develop a core set of gender indicators for Asia and the Pacific. The Committee will also have before it the proposed core set prepared by the secretariat in consultation with members and associate members, development partners and experts. The core set and underlying statistics are intended to capture the statistical information required to address issues of high priority in promoting gender equality and empowerment of women in the region.

The Committee is invited to review and adopt the core set of gender indicators for Asia and the Pacific as a minimum range of gender statistics that all countries in the region can aspire to produce and disseminate. The Committee is also invited to provide guidance on using the core set to strengthen national and regional efforts to integrate a gender perspective in statistics in Asia and the Pacific and to contribute to the successful implementation of the development agenda beyond 2015.

4. Global initiatives: agricultural and rural statistics

Annotation
