




I. Efficient and resilient transport and logistics networks and mobility for economic growth: CONTEXT

Connectivity level index of selected Asia-Pacific countries, 2021



Relative growth in freight activity in Asia and the world



- Connectivity levels remain heterogenous across the region and countries in special situations are particularly impacted by the recent and ongoing shocks to connectivity
- ☐ The pandemic is not expected to reverse or stop the projected freight growth in Asia
- ☐ Efficient and resilient multimodal transport is essential for meeting the current and future freight demand





I. Efficient and resilient transport and logistics networks and mobility for economic growth: LAND CONNECTIVITY

- □ Continued progress in the coordinated infrastructure development along the AH and TAR networks and in the dry port development
- Digitalization leads to renewed efforts in facilitating transport and harmonizing operational standards, as appropriate, including cross-border and transit requirements. A rail digitalization strategy is a key recommendation. A new annex to the TAR Agreement is to be considered by Parties.
- ESCAP Model Subregional Agreement on Transport Facilitation now contains **crisis related provisions**
- □ Support to multimodal transport corridors and operations through the finalization the "Guidelines for harmonization of national laws on multimodal transport in Asia and the Pacific".

Special focus on:

- Support to countries in special situation
- Inclusiveness and quality of the logistics sector
- Evidence-based approaches in the development of the regional transport system

II. Enhancing sustainable freight transport in Asia and the Pacific

- ☐ Increased importance of sustainable freight during the decade of action for the Sustainable Development Goal
- □ 2020: COT, 6th session, recommended that concrete collaborative initiatives on sustainable freight be taken up within the ESCAP regional mechanisms
- 2021, May-June: The intergovernmental Working Groups on the Asian Highway, Trans-Asian Railways and Dry ports discuss and support a regional approach on sustainable freight
- □ 2021, December: the MCT4 Ministerial Declaration calls for supporting a rmonized regional approach in this area



II. Objectives and scope of the guiding principles

- ☐ Deepen the linkages of policies and strategies on freight transport with the realization of Agenda 2030 by consolidating priority actions on sustainable freight transport
- □ Ramp up funding, technical assistance, and capacity building on sustainable freight transport through partnerships and multistakeholder collaboration;
- ☐ Fortify the political affirmation for urgent measures to deepen freight sustainability in Asia and the Pacific in the decade of action for sustainable development goals



Issues for consideration

☐ Provide **feedback and guidance to the secretariat** on ongoing and planned activities on efficient and resilient transport and logistics networks, including the **proposal on a new TAR annex** on electronic information exchange ☐ Welcome the Guidelines for harmonization of national laws on multimodal transport operations in Asia and the Pacific and the revised Model Subregional Agreement on Transport Facilitation Call for renewed support to enhance the transport connectivity of the countries in special situations, including through initiatives such as the creation of a regional strategy to accelerate rail digital transformation in Asia and the Pacific; ☐ Welcome the initiative to establish the **interactive platform on the Asia-Pacific Transport Network**, and request members and associate members to work closely with the secretariat on finalizing the content ☐ Take note of the conclusions of the Regional Forum on Connecting to Global Supply Chains, requesting the secretariat to follow up on the proposal to create a regional approach to green shipping corridors and to continue supporting the initiatives to develop land and multimodal transport corridors ☐ Consider endorsing the 10 Guiding Principles on sustainable freight transport in Asia and the Pacific
