In alignment with global trends, this event aims to address the increasing importance of sustainability and climate disclosure and its implications for financial institutions (FIs) and businesses. Amidst growing awareness of environmental risks and stakeholder demands for transparency, the event will highlight challenges and best practices in sustainability reporting, drawing on global insights to provide context for Mongolian stakeholders. Moreover, leading companies in Mongolia will share their experiences in integrating sustainability into their business strategies and navigating the evolving landscape of reporting requirements.

Notably, the event will feature the dissemination of climate-related information disclosure guidance explicitly tailored for Mongolian FIs, equipping them with practical examples to enhance their sustainability reporting practices. Through knowledge exchange and collaborative engagement, this side event endeavors to catalyze actionable steps towards a more resilient and environmentally responsible business environment in Mongolia.
