OBJECTIVE

The main **objectives** of tourism statistics are the organization of statistical monitoring of tourist flows, places of their accommodation, travel characteristics, wholesale and retail trade, transport, construction, employment, financial intermediation, income and expenses related to tourism, on the basis of a unified scientific methodology that complies with international rules and standards.

Information from Border Service under State Committee of National Security KR

Data (Report) on the number of crossings (arrivals, departures) of the state border by countries and purposes

Periodicity: quarterly and since the beginning of the year

By countries: all countries by codes and names

Purposes: private, tourism, official, work, education, religious, immigration, service staff

Data can be use for publication and analysis

- Unified state register of statistical units includes all legal units and individual entrepreneurs. It is general basis for all statistical surveys
- Statistical surveys of travel companies, hotels, guest houses, resorts, sanatoriums and etc. on quarterly basis
- Summer and winter survey (June- August, December-February)
- Complete summer survey guest houses in Issyk-Kul region
- Sample summer household survey in Issyk-Kul region
