




SOUTH AND SOUTH-WEST ASIA SDG UPDATE

The burning of crop residues contributes to the creation of severe air pollution in the subregion and is an ongoing challenge in the pathway toward achieving the SDG Goals.

"Sustainable Management of Crop Residues in Bangladesh, India, Nepal, and Pakistan: Challenges and Solution" was recently published by ESCAP-SSWA and the Centre for Sustainable Agricultural Mechanization (CSAM) to better understand the status of crop residue management in South Asia. Crop residue burning is a major reason for severe air pollution in the Indo-Gangetic plain region. Crop residue burning increases the concentration of particulate matter and black carbon in the air, adversely affecting the health of both rural and urban populations. This burning degrades soil fertility that needs to be compensated by greater use of fertilizers, and can reduce agricultural productivity in the long run. Greenhouse gases emitted from burning also contribute to global warming and climate change. All of these factors adversely affect the achievement of the Sustainable Development Goals as crop residue burning harms our health and wellbeing (SDG 3), has implications on food security (SDG 2), affects the air quality of city inhabitants (SDG 11) and contributes to climate change (SDG 13).

This paper provides a subregional overview of the status of crop residue management in Bangladesh, India, Nepal and Pakistan. Based on findings from national studies undertaken, the paper provides an overview of the amounts of crop residues produced, the in-situ and ex-situ management techniques utilized by farmers to make use of residues and the existing challenges, the major factors that influence their burning and the various socio-economic and environmental impacts that such burning has in the subregion. An overview is also provided of the different kinds of agricultural machinery used to manage crop residues in the study countries, government efforts to reduce the level of burning, and the various technologies that exist to use biomass for power generation.

The report provides an overall picture of the gaps and offers a set of necessary policy interventions, action plans and recommendations, such as the promotion of gasification technology, propagation of conservation agriculture practices, and development of mechanisms for aggregation of crop residue biomass.

The paper also touches upon the major areas identified for subregional cooperation for integrated crop residue management, such as joint research and analytical studies, creating reliable supply chains for aggregation of crop residue biomass, sharing and popularization of technologies, equipment and practices for in-situ and ex-situ management of crop residues as well as harmonization of testing standards and promoting more integrated trade of

Ms. Thinley Yangzom, Founder of Bhutan Superfoods and Herbs, shared, "Because of the COVID-19 pandemic, my business was hugely impacted and had to shut down. But thanks to these trainings, I learnt about e-commerce and digitally marketing my business to expand my reach."

"In today's world, it is essential to be able to showcase products online, and we appreciate the effort that ESCAP has made to support women entrepreneurs to this end. The ESCAP training platform has enabled us to practise showcasing our work and products on e-commerce sites." Ms. Sujata Chatterjee, Founder of Twirl.store India, further elaborated.

Ms. Tazima Hossain Majumdar, Owner of Needle Craft, Bangladesh echoed the sentiments of the other women entrepreneurs, "I learned how to upload my product profile on e-commerce platforms for women entrepreneurs. The training helped me learn about using digital marketing sites to generate and connect with new customers from South Asia."

The success of the initiative could be attributed to its hands-on practical sessions, coupled with the facilitation of networking opportunities and real time support among fellow female participants through WhatsApp and Facebook groups. A Facebook page was also established to encourage female entrepreneurs to share their entrepreneurial stories as well products and services.

Due to its achievements, the initiative was <u>featured as a good practice</u> in the 2022 Global South-South Development (GSSD) Expo - hosted by the Government of Thailand, ESCAP, and the United Nations Office for South-South Cooperation from 12 to 14 September 2022, in conjunction with the 2022 UN Day for South-South Cooperation.

Bangladesh

The honourable delegate of Bangladesh shared that the country has recently celebrated its 52nd Independence Day and has made significant progress in achieving the Sustainable Development Goals (SDGs). As one of the most populated countries in the world and a leading economy in South Asia, Bangladesh is on track to graduate from the category of Least Developed Countries (LDCs) by 2026 and aims to achieve the SDGs by 2030. The country has shown remarkable advancements in social and economic development, supported by a well-educated

promoting and implementing the SDGs. The country has set 40 national priority indicators for local-level implementation of the SDGs. Despite the challenges posed by the COVID-19 pandemic, Bangladesh has achieved an average GDP growth of 6.3% over the past 14 years, with a growth rate of 7.4% in 2021-2022. The government has addressed the initial challenges of the pandemic by providing logistics, recruiting healthcare professionals, and vaccinating a majority of the population. Bangladesh has also made significant progress in ensuring access to electricity and housing for the homeless. The country has launched the Mozi Climate Prosperity Plan 2030, which aligns with the financing of the 8th Five-Year Plan, Mission 2040, and Bangladesh Plan 2100. Despite the difficulties faced by developing countries in achieving the SDGs by 2030, Bangladesh believes that coordination, partnership, cooperation, and sharing experiences will be crucial for achieving these goals. The country encourages regional cooperation to facilitate inter-regional trade, paperless transactions, and improved connectivity through investment networking. The government, under the leadership of Prime Minister Sheikh Hasina, has implemented peoplecentric initiatives aimed at achieving its vision for development by 2040.



India

The honourable delegate of India highlighted India's steady progress towards achieving the Sustainable Development Goals (SDGs) in various areas including clean water, sanitation, clean energy, and infrastructure. The Government of India has implemented initiatives such as housing for all, universal access to electricity, and clean cooking gas to improve the quality of life, particularly in rural areas. India has prioritized sanitation and water access through flagship programs like the Swachh Bharat Abhiyan and Jal Jivan Mission. The country has made significant strides in reducing multidimensional poverty, with 415 million people escaping poverty between 2005 and 2021. India is committed to climate adaptation and mitigation, aiming to reduce emission intensity and achieve a significant share of non-fossil fuel-based energy resources by 2030. The Government has approved the Green Hydrogen Mission and promotes a circular economy through the "LIFE" movement, emphasizing a lifestyle that aligns with environmental sustainability. India has also made progress in infrastructure development, innovation, and logistics efficiency. The country's focus on sustainability is evident in initiatives like the National Logistic Policy and the implementation of national missions for clean housing, smart cities, and environmental conservation.



Islamic Republic of Iran

The honourable delegate of Iran highlighted challenges faced by the Islamic Republic of Iran in relation to global climate change and limited water resources. The country experiences extreme weather events such as floods, droughts, and sand and dust storms, which have severe consequences for human health and the environment. Efforts have been made at national, regional, and international levels to address these issues, including the establishment of a regional coordination group for sand and dust storms. Iran also hosts a significant number of Afghan refugees and calls for international assistance to meet their needs, particularly in terms of clean water and sanitation. The honourable delegate also highlighted the negative impact of unilateral measures on Iran in hindering access to essential resources and impeding the achievement of sustainable development goals. Developing countries require adequate and predictable support from developed nations in terms of financing and technology transfer. The energy system should prioritize affordability, availability, and environmental sustainability, promoting a comprehensive and balanced approach rather than relying solely on one energy source. The Islamic Republic of Iran expressed its willingness to collaborate with other countries to achieve shared objectives and ensure sustainable development for developing nations.



Maldives

The honourable delegate of Maldives highlighted the challenges faced by countries in Asia and the Pacific in achieving the SDGs. The honourable delegate emphasized the need for urgent and concentrated efforts, particularly in Sustainable Cities and Communities, Responsible Consumption and Production, and Climate Action.

The honourable delegate emphasized the need for cooperation and solidarity, especially in the aftermath of the COVID-19 pandemic. The Maldives looks forward to presenting its second Voluntary National Review and called for support from all stakeholders to achieve the 2030 Agenda.



Nepal

The honourable delegate of Nepal emphasized the importance of Sustainable Development Goals (SDGs) in Nepal's vision and priorities. Nepal has integrated the SDGs into national plans and programs, localizing them at the provincial and local level. The implementation of SDGs involves various stakeholders, including social, civil society, and development partners. While progress has been made in areas like poverty reduction, food security, education, health, gender equality, and energy, the COVID-19 pandemic and global conflicts have hindered Nepal's development efforts. The pandemic has led to increased poverty and unemployment rates, widened wealth disparities, and disrupted supply chains. Rising food and energy prices, outstanding debt, fiscal deficits, and inflation have posed additional challenges. The Government is implementing recovery policies and strategies to mitigate these impacts, providing relief packages and support to affected sectors. Social protection and digitization initiatives are prioritized, while structural reforms are needed to boost economic growth and resilience. Collaboration among global initiatives, development partners, and stakeholders is crucial to accelerate SDGs implementation and address the challenges posed by the pandemic and other crises.



Pakistan

The honourable delegate of Pakistan highlighted the partnership with ESCAP in organizing the Sixth South and South-West Asia Forum on the SDGs in 2022 in Islamabad. The honourable delegate highlighted that the Asia-Pacific region as a whole, including South Asian countries, is lagging behind in achieving the targets of all 17 Sustainable Development Goals (SDGs) according to the global review of the SDG report 2023 and the SDG forum report 2022. It is concluded that countries need to focus on priorities not only at the national level but also at the sub-regional level due to the cross-boundary implications of many issues. Pakistan has faced a triple crisis of COVID-19, international conflicts, and floods in 2022, which has deeply impacted the country's economic and social sectors. Developing countries were provided assistance during the COVID-19 pandemic, but in the recent crisis, they were asked to increase prices and abolish subsidies, leading to a deteriorating balance of payment system, economic shrinkage, high inflation, and historically low reserves. The honourable delegate emphasized the need for a joint financing mechanism in the Asia-Pacific region without adverse conditionalities during emergencies. They call for unity in establishing trade routes, exploring mutual investment opportunities, reducing trade costs, developing a regional electricity market focused on renewable energy, and improving transport infrastructure for a green and clean environment. Long-term financing, sustainable growth, policy consistency, investment in social protection and resilient infrastructure, agricultural and rural transformation, and cross-border trade are highlighted as essential for achieving the SDGs. Regional cooperation is emphasized to address transboundary challenges such as climate change, natural disasters, ecosystem degradation, and ocean contamination. The honourable delegate suggests convening a regional conference every two years to assess the impact of transboundary challenges and monitor progress in this area.



Sri Lanka

The honourable delegate of Sri Lanka shared that the country's second voluntary national review (VNR) helped renew ownership of the 2030 Agenda among stakeholders. Conducted during the COVID-19 pandemic and its economic consequences, the VNR allowed self-reflection and exploration of innovative pathways to address challenges. The government ministries and agencies have taken ownership of specific SDG goals and targets, aligning national development programs accordingly. Limitations in the data ecosystem were identified, and efforts

developed the first-ever SDG Investor Map through collaboration between government agencies, the private sector, and UNDP Sri Lanka. Institutional mechanisms for political oversight of the SDG process are being designed and institutionalized in Sri Lanka based on lessons learned from the twinning program with Pakistan. Sri Lanka is committed to implementing VNR recommendations and values the experiences shared by other regional countries. Thanks are extended to UNESCAP for their support in the VNR process and for continuing to assist in implementing VNR recommendations.

Indian economy grew at 4.4% between October and December 2022 and it's expected to grow at 7% during the current financial year 1 March 2023. 
