Summary of advance electronic consultations among member States

- The Committee acknowledged the importance of embracing the use of big data for the implementation of the 2030 Agenda for Sustainable Development and the Declaration on Navigating Policy with Data to Leave No One Behind;
- The Committee noted with appreciation the increased efforts to use big data for the production of official statistics in Asia and the Pacific;
- The Committee noted the demand for new methods, technologies and skills is a challenge for national statistical offices;
- The Committee recognized regional and international collaboration on using big data for official statistics can further support national efforts and strengthen national capacities through piloting and sharing of best practices, research, experimentation, and experiences.

Proposed draft decision

- The Committee decides to feature big data for official statistics in its future work with an emphasis on sharing country research. experiences and best practices.
- The Committee requests the Bureau to propose, in consultation with the secretariat, modalities to that end for review and approval by the Committee, while bearing in mind the need to stay within existing regular budget resources.
