 - 71 participants from 19 countries.







Agenda item 4 (c): (cont'd)

Summary of advance electronic consultations among member States

- The Committee acknowledged the changing technological landscape in the production of statistics and the associated skill requirements
- Members of the Committee noted the need for human resource reforms and skills audits in a changing technological environment remains a critical part of institutional reforms
- The Committee noted the various initiatives in strengthening staff skills such as e-learning programmes, in-house training programmes, talent identification and development programmes
- Members noted that statistical institutional strengthening should be a priority in management and development of human resources in statistical agencies







Agenda item 4 (c): (cont'd)

Proposed draft decision

- The Committee decides that strengthening of statistical institutions, including improving training infrastructure, and the development of training programmes to address regional skills gaps in line with the 2030 Agenda for Sustainable Development should be made a priority feature in its work
- The Committee requests the Bureau to propose, in consultation with the secretariat, modalities to that end for review and approval by the Committee, while bearing in mind the need to stay within existing regular budget resources.
