



Summary Assessment

Committee on Statistics, sixth session Bangkok 16-19 October

I. Introduction

The Committee on Statistics, sixth session was held in Bangkok, Thailand, from 16-19 October 2018.

A questionnaire assessing the relevance, effectiveness and quality of the meeting was distributed to each delegation of ESCAP members and associate members. In total, 26 of the 29 members and associate members in attendance submitted questionnaires. The overall response rate is therefore 90 per cent. The present assessment was prepared on the basis of these questionnaire responses.

The main purpose of this assessment is to support the secretariat's ongoing efforts to improve its servicing of session.

II. Attendance

The Committee on Statistics was attended by 47 per cent of all ESCAP members and associate members (29 of 62). Some 25 of delegations (86 per cent) were headed by officials from the respective capital, including 1 participant at ministerial level. In total there were 110 individual participants, of whom 43 were female (39 per cent).

A number of other entities participated, including United Nations bodies and agencies, intergovernmental organizations, and non-governmental organizations. From these entities, there were 44 participants of whom 21 were female (49 per cent). Therefore, the total number of participants from both governments and other entities is 154 individuals and the total number of female participants is 64 (42 per cent).

III. Relevance of the session

Respondents agreed that the agenda items reflected the present development trends and issues in the Asian and Pacific region. The respondents also rated positively on relevance to the needs and priorities of their countries/territories (See table 1).

There were some suggestions and comments on the relevance of the session:

- Sessions were relevant with the participating countries.
- Excellent! Yes, relevant
- Environmental Statistics Land, Water, Forest
- We have learned from other member countries experiences in adapting and implementing of the NBDS as well as the government policy on national social economic development and their progress on implementing the SDG at the national level. Therefore, we hope that the workshop/seminar on sharing good practices is encouraged to countries.

IV. Effectiveness of the session

The respondents rated favorably agenda item 11 on member States' perspectives on navigating policy with data to leave no one behind; and agenda item 7 on consideration of the draft declaration on navigating policy with data to leave no one behind. Good reviews were made regarding the session effectiveness in identifying priority areas and emerging issues in the region; and that the session documents were of high quality, concise and clear. (See table 2).

There were some suggestions and comments on the effectiveness of the session:

- Encourage members to make statements
- Maybe Secretariat can follow-up with attending members what they do with the Declaration if they have make any difference relating to 2030 Agenda or role of NSOs in the country.

V. Efficiency of the session

The respondents rated positively on the time available for discussion during the session. The respondents also rated positively that the organisation of work prior and in between Committee sessions enabled the session to proceed effectively, in particular, the Bureau; the Steering Group for the Regional Programme on Economic Statistics; and the Regional Steering Group on Population and Social Statistics (Table 3).

There were some suggestions and comments on the efficiency of the organizational and servicing aspects of the session:

- Updated version of the power point slides should be posted on the web. These new set of slides were already given to the conference officer.
- A bit of improvement in the communication.
- I thought the photo booth and display was a good initiative. Well done team!

- Generally, I think there is a lot of repetition in the meetings. I think moving the meeting along faster would keep people more engaged allow more topics to be covered, be more efficient with everyone's time. You have an informed audience so pushing us harder I think is appropriate.
- Allow coffee mugs in the Conference Room to keep people stay inside and not fall asleep during the meeting. Request participants to read relevant documents before each session to make discussions more alive or Secretariat can provide folder with all materials to make sure everyone read the documents and get engaged. Chair or Secretariat to stimulate discussions on issues. I felt that the meeting lacked debates and real dialogue on issues, maybe member States all share the same understanding so there was nothing new to talk about!

Make the sessions more engaging maybe presentation instead of country statements.

Overall, in conclusion, responding delegations agreed that the sixth session of the Committee on Statistics was successful.

The session was positively seen as relevant to the needs of the region; including in highlighting regional development trends and issues. The efficiency of the session also received very positive feedback, in particular, the time available for discussion during the session.
